This privacy policy describes how we collect, use, protect and share information about the companies we do business with, including those companies' representatives, as well as rights regarding personal information. By using our website and participating in our services, you agree to the collection and use of information in accordance with this policy.

Collection and Use of Information

In our B2B interactions, we collect different types of information for different purposes to provide and improve our service to you and your business.

Types of data collected

Business Contact Information: We collect information typically connected with business-to-business transactions. This may include, but is not limited to:

- Company name
- Company address
- Contact name
- Email address of the contact person
- Telephone number of the contact person
- Type of industry
- Company size and other relevant details

Log Data: We also collect information about how the website is accessed and used. This Log Data may include details such as your computer's Internet Protocol address (e.g. IP address), browser type, browser version, the pages of our Website that you visit, the time and date of your visit, the time spent on those pages and other relevant data.

Cookies: Cookies are files containing small amounts of data, often used as anonymous unique identifiers. These are sent to your browser from the website you visit and stored on the hard drive of your computer. Our website uses these cookies to collect information and improve our service. You have the option to accept or refuse these cookies, and to be notified when a cookie is sent to your computer. If you choose to refuse our cookies, you may not be able to use certain parts of our website.

Use of data

De Visser Trading b.v. uses the collected data for various purposes, including:

- To provide and maintain our service

- To inform you of changes to our services
- To enable you to participate in interactive features of our service when you choose to do so
- To provide customer support
- To collect analyzes or valuable information so that we can improve our services
- To monitor the use of our service
- To detect, prevent and address technical problems

Sharing and Disclosing Data

De Visser Trading b.v. may disclose your business contact information and other information to third parties under the following conditions:

Service Providers: We may employ third party companies and individuals to facilitate our services on our behalf, to perform Service-related services or to assist us in analyzing how our Service is used. These third parties have access to your business contact information only to perform these tasks on our behalf and are obligated not to disclose or use it for any other purpose.

Legal requirements: De Visser Trading b.v. may disclose your information when required to do so by law or in response to valid requests from public authorities (for example, a court or other government agency).

Retention period of the data

The data will be retained for another twelve years after the end of the customer relationship with De Visser Trading b.v.. The statutory retention period applies to customer correspondence, order and payment history.

Right to deletion

You have the right to immediate deletion of your personal data, to the extent that one of the following reasons applies and to the extent that the processing is not required:

- The personal data has been collected or otherwise processed for purposes for which it is no longer necessary.
- You withdraw the consent on which the processing was based and there is no other legal basis for the processing.
- You object to the processing pursuant to Article 21(1) AVG and there are no overriding legitimate grounds for the processing, or you object to the processing pursuant to Article 21(2) AVG.
- The personal data was processed unlawfully.
- The deletion of personal data is necessary to comply with a legal obligation under European Union or Member State law to which we are subject.
- The personal data was collected in connection with information society services offered in accordance with Article 8(1) AVG

Right to object to processing

You have the right to object to the processing of your personal data at any time on the basis of Article 6 paragraph 1 e or f AVG.

In the event of an objection, we will no longer process your personal data unless we can demonstrate compelling legitimate grounds for the processing which override your interests, rights and freedoms, or the processing serves the establishment, exercise or defense of legal claims.

You have the right to object at any time to the processing of your personal data for direct advertising purposes.

Data security

We appreciate your trust in providing us with your personal information. Therefore, we strive to use commercially acceptable means to protect it. But remember that no method of transmission over the Internet, or method of electronic storage is 100% secure and reliable, and we cannot guarantee its absolute security.
